Minutes:

1. The President opens the meeting at 4.05 p.m.

He recalls to mind Prof. S. Czarnecki and Prof. T. Nimura who both died since the last meeting of the Board. An obituary on these two active members was published in the Newsletter.

A minute of silence is observed.

2. The present agenda is accepted.
3. The minutes of the eight meeting of the Board held in San Francisco are approved.
4. The president presents the state of affairs with regard to memberships of I-INCE on 1st April 1983 (See appendix 1).

The Österreichischer Ring für Lärmbekämpfung (OAL) joined I-INCE on 1.6.82. Since then the number of the member societies remained the same, namely 23 from 21 countries.

Brüel and Kjaer, Computer Engineering Ltd (CEL), Norwegian Electronics and Rion became sustaining members. This brings the total number to five. Until now no associate members were registered. Continuous effort must be made by the members in order to gain new members.

A request from Norwegian Electronics to the effect that the annual dues paid by sustaining members should have relation to the size of the organization could not be complied.

The list of the acoustical societies which were approached for an eventual membership is extended in detail. No answer was received from GALA. Spain and Portugal are waiting. W. Lang will contact Prof. Gvishiani (U.R.S.S.). There are some contacts with B.W. Heng of Singapore. More especially the President regrets the absence of the GALT.

5. The audited accounts for the fiscal year 1982 are approved (see appendix 2). There is a credit-balance of 121.523 Belgian Francs (\pm 2.400 U.S. dollars).
6. The General Secretary presents the budget for 1984 (see appendix 3) which is accepted.
7. Some steps were already taken in the past in order to organize an Inter-Noise Congress in China in 1985. After a discussion in San Francisco, 1987 was proposed. The President feels that the situation must be clarified before an official letter is sent. Further discussion will be held in Edinburgh.
8. Report from the Editor of Newsletter

The editor proposes to increase the number of copies for all member societies to a maximum of 100 copies. Those societies who like to have more copies can get them by payment. A letter will be written to all member societies to inform them.

A proposition is also made to reintroduce the contents of Acoustical Journals. Some members of the board are in favour, especially those from Eastern European Countries, others are opposed to it. It was decided to publish short contents of the most important Journals, especially those items which are related to Noise Control. This will be done in connection with Noise News of INCE U.S.A. (editor Dr. G. Maling).

9. UITA

The invitation to join "The Union of International Technical Associations" (Appendix 4) is examined. The conclusion is negative.

10. Bruit^N

The president feels that there is no hurry whether to collaborate or not with the "Biological Research Unit for Intensive Treatment of Noise, Bruit^N" (Appendix 5).

He will discuss this matter with J. Mattei in Paris.

11. Inter-Noise 83

On behalf of Prof. Richards who had to leave for another meeting, Dr. Leventhall gave some details on the organisation of Inter-Noise 83. There are 650 participants from 38 countries.

12. Inter-noise 84

W. Lang distributes a blue folder with details concerning the meeting in Hawaii (see Appendix 6).

The poster session will not be in competition with the lecture session.

13. Inter-Noise 85

Prof. R. Martin gives detailed information on the congress which will be organised by the V.D.I. at the University of Munich (see Appendix 7).

14. Other items

Prof. Engel announces the organisation of a satellite congress on 24-26 September 1985 in Cracow. It will be organised to remember Prof. Czarnecki and the topics will be noise control and machinery vibrations.





INTER-NOISE 84, the thirteenth International Conference on Noise Control Engineering, will be held at the Hotel Ilikai in Honolulu, Hawaii, 1984 December 03-05. With the theme "International Cooperation for Noise Control," the conference will be sponsored by the International Institute of Noise Control Engineering (I/INCE) and organized by INCE/USA in cooperation with INCE/Japan. This will be the first time that two member societies of International INCE have cooperated in the organization of an INTER-NOISE conference, which will include technical sessions consisting of invited and contributed presentations on world-wide noise-control technology as well as poster sessions and an exhibition of the latest equipment and instrumentation for noise control. A series of distinguished lectures will be presented by recognized specialists. The emphasis during INTER-NOISE 84 will be on practical solutions to important noise control problems. A bound copy of the Proceedings will be available to participants at final registration and by mail to others after the close of the conference.

CONTRIBUTIONS INVITED

Contributed papers are welcome. An abstract is required for every conference paper. Limit each abstract to 200 words, including equations and references. It should describe new work that has not previously been presented at a conference or published in a journal. Authors must include name, complete mailing address, telephone number and one or two subject classification numbers under which the abstract may be indexed (see the INCE Classification of Subjects on the reverse side). Type double-spaced on one sheet of letter-sized paper. Include all pertinent information on this one sheet of paper; a cover letter is not necessary. Send three copies of each abstract to: William W. Lang, Chairman, INTER-NOISE 84, P.O. Box 3469 Arlington Branch, Poughkeepsie, NY 12603, U.S.A. The deadline for the receipt of abstracts is 1984 March 15.

INTERNOISE '85

INTERNOISE '85 will be held in the buildings of the Munich University from Wednesday, September 18 to Friday, September 20, 1985. So far, a large lecture hall seating 600 has been reserved for the opening ceremony and six smaller halls for parallel sessions.

It is also planned to arrange a special exhibition on the conference topic in the foyer.

Before the beginning of the congress, a one-week tour of the Federal Republic of Germany will be organized in order to give foreign participants the opportunity of visiting the most important centres of acoustic research.

On the day following the end of the congress, the Munich October festival will be opened. Perhaps some of the participants will be interested in a visit to this famous festival. Hotel rooms should therefore be reserved as early as possible.

At the congress itself

- plenary papers of 45 minutes
- invited papers of 30 minutes and
- brief papers of 15 minutes

will be presented.

The language of the congress will be exclusively English.

A social gathering will be held on one of the evenings during the congress.

It is planned to establish a program committee, comprising, if possible, experts from neighbouring European countries, in order to keep low any travel expenses which may arise.

Please submit your proposals concerning experts to be invited to cooperate in this program committee before the end of 1983 to: VDI-Kommission Lärm-minderung, Postfach 1139, D-4000 Düsseldorf 1 (Fed. Rep. of Germany).

On behalf of the chairman of the VDI Commission "Noise Reduction", it gives me great pleasure to most cordially invite all those present to participate in INTERNOISE '85 in Munich.
