Agenda item 1. Opening of the meeting

The President (F. Ingerslev) opened the meeting and welcomed the members of the Board and the observers.

According to the Rules of Procedure (see Circular Letter No.1) the Board is legally competent to transact business only when half of the members of the Board are present. The results of the discussion will therefore have to be circulated to all members for possible approval.

Agenda item 3. Report by the President on the activities of I/INCE

It was reported that:

a) 4 societies have been elected members of I/INCE, i.e.

The Acoustical Society of Japan

- Norway

The Acoustical Society of Denmark INCE/USA

- b) Switzerland has sent an application for membership. The Association of Noise Control Engineers, U.K. sent an application some months ago. The President has had some correspondence with the Association to clear up some problems. A Circular Letter concerning this applications will be send to the Board in the near future.
- c) Societies considering to join I/INCE. A.S.A. will consider the matter in November. It was reported that A.S.A. is favorably inclined. Prof. Stephens has announced in March that the British Institute of Acoustics is interested in joining I/INCE. Nothing has been reported to the President since that time.

Canada is considering.

South Africa will in the near future establish the South African Acoustical Institute and it is likely that this institute will join I/INCE.

Mr. Strumpf, Israel, has indicated that Israel is interested. An Acoustical Society of Israel has now - according to Strumpf - been established.

- d) Societies wanting various information.
 G.A.L.F., Australia and Hungary want various information which will be send by the President.
- e) Societies who have declined to join I/INCE:
 Belgium and Sweden
 Reason given: too expensive.
- f) Clarification within the country. DAGA in Germany. It is questionable whether DAGA or another organisation - VDI - should join I/INCE. No official answer has been received.
- g) Invitations to join I/INCE. Invitations were sent in the middle of August to Austria - Egypt - Spain - G.A.L.A.

h) Countries in Eastern Europe.

There was a discussion of the situation when a country in Eastern Europe does not have a society which is "open to membership for individual persons". It was proposed that in such cases it will be correct to accept that the country has a system which is different from the "normal" system and thus accept that a national committee be elected as member. The problem shall, however, be studied carefully in each case.

i) Other countries.

Agenda item 5. Discussion on possible changes in the BYLAWS

a) Board of Directors.

It is stated in the BYLAWS, that one of the six Directors shall represent the International Commission on Acoustics (ICA). The Director representing the ICA is designated by the President of that organization.

Dr. Mattei - being the present Director representing the ICA - has send the President a letter (see Appendix C) in which he expresses the wish of the ICA that changes be made in the BYLAWS of I/INCE since ICA is a specialized commission of IUPAP and can take no direct responsibilities on the Board of I/INCE.

The Board members present at the Sendai meeting discussed Dr. Mattei's letter thoroughly. The conclusion of the discussion was that the members present felt it is of utmost importance that I/INCE has a proper liaison with ICA. The meeting had also the opinion that the ICA would not assume any responsibility by designating a member of the Board of I/INCE.

b) Membership.

The secretary of The Association of Noise Consultants (ANC) in U.K., Prof. J.B.Large, asked in a letter of 7th April 1975 whether ANC would be eligible for membership in I/INCE.

The members of the Board present in Sendai discussed this application as a matter of principle.

Even it is clear that a closed organisation as ANC can not be eligible for membership in I/INCE, there was a sympathic attitude to such organizations and an understanding of the wishes that such organizations may have in establishing the closest possible contact with I/INCE.

It was discussed whether it in the future a possible solution would be to introduce "Associate Membership" and organizations like ANC could be elected as associate members.

It was clear that such a step would require careful study and that no discussion of changes of the BYLAWS with the purpose of introducing associate membership should take place before the election of members according to the present BYLAWS has been brought to a reasonable conclusion.

The problem will be placed on the Agenda for one of the following meetings of the Board.

c) Finance.

The member societies are requested to assist in defraying the operating expenses of the Institute, including the publication of the Newsletter. The sum to be paid by each member society is fixed at 300 Swiss Francs in the BYLAWS.

It was pointed out during discussion in the corridors in Sendai by a representative of one of the countries that his country was unable to accept that the sum of 300 Swiss Francs could be changed at the Board's discretion (The Board has the right to change the BYLAWS).

The members of the Board agreed that it will be proper to require that a proposal from the Board concerning a change in the sum to be paid by a member society could be effective before this proposal has been approved by The General Assembly.

The BYLAWS shall in due time be adjusted according to this proposal.

The members of the Board present at INTER-NOISE 75 promised the said representative that they will recommend to the Board that the sum of 300 Swiss France be frozen until the change in the BYLAWS is effective.

d) Withdrawal of membership of I/INCE.

It has been noted that the BYLAWS do not give any rules concerning withdrawal of membership. It may be advisable to incorporate such rules when the BYLAWS are revised.

Agenda item 6. Report on INTER-NOISE 76

George Maling gave a short report on INTER-NOISE 76. Peter Baade is appointed as General chairman and the organization will be undertaken by The Pennsylvania State University.

Agenda item 7. Other items

a) INTER-NOISE 77

The composition of the Organization Committee at an INTER-NOISE CONFERENCE shall be approved by the Board before the public announcement at the conference. The Swiss members of the committee have already been elected. It is understood that the Committee shall have a number of members from other countries. It was agreed that the President should send a letter to the Swiss Organizing Committee indicating a number of names of candidates for membership of the Organizing Committee among which the Swiss Organizing Committee among the Committee may wish to select some to serve as members of the Committee.

b) Host Society for INTER-NOISE 79.

The Agenda for the next meeting of the Board will have an item "The host society for INTER-NOISE 79". Possible

candidates were discussed in Sendai. It will be advantageous to postpone this question until the election of member
societies is at a more advanced stage. It is hoped that
the Board after the next meeting will be able to invite a
member society to undertake the organization of INTER-NOISE
79.

c) International INCE Master List.

It would be of value to develop a list of associations and organizations around the world which have programs in research on noise control and application of engineering techniques for the control of noise.

George Maling promised to make the first draft for this list. He will use the list developed by ICA as the basis for the I/INCE Master List. An extensive enlargement of the ICA list is foreseen.

Dear Ingerslev,

The relations between IINCE and ICA have been discussed at the Rome meeting of the International Commission on Acoustics.

After a careful study of INCE bylaws and of IUPAP statuts, we unanimously came to the conclusions that ICA as specialised commission of IUPAP could not have direct responsabilities in the Board of Director of IINCE. Therefore the commission could not appoint one of it's members as Director of IINCE. In order to keep a liaison with IINCE to coordinate common activities it was suggested that there is a possibility of appointing an observer at the general assembly. Which could be between meetings in relation with the Board of Directors if the Board of Directors of IINCE wishes so.

This position is not very far from what I have written in September 74 to Dr. RATHE (see enclosure). Therefore I suggest that you take the opportunity of the next meeting of the Board of Director, schedul in August in Japan, to change the bylaws.

On change should be :

Section 3, third paragraph, delete "one represent the International Commission on Acoustics".

The other could be if the Board agree :

Section 4, first paragraph after "one representative of each member society" add. "and one observer of the International Commission on Acoustics".

As there is a general assembly of IUPAP in September.

Could you let me know the decision taken by the Board of Director about those changes.

I apologizes for giving you some extra work and I hope that in spite of those changes the good cooperation between IINCE and ICA could be carried on.

Would it not, therefore, he appropriate that, as you complete your term as ICA President, the incoming ICA President appoint you personally as the International INCE Director representing the ICA.

I hope that I will be able to come to the F.A.S.L. meeting at the end of September, and that I can have

the opportunity of discuss the matter with you.
