MINUTES OF THE 35th MEETING OF THE GENERAL ASSEMBLY SUNDAY, 2009 AUGUST 23 OTTAWA, CANADA

1. Opening:

President G. Daigle opened the General Assembly meeting at 13.05 on Sunday, 2009 August 23 in the Governor General 2 Room in the Westin Ottawa Hotel in Ottawa, Canada.

3. Adoption of the Agenda:

The draft agenda was reviewed and approved. The approved agenda is appended as Attachment 1.

4. Minutes:

The President asked for comments or corrections to the Draft Minutes of the 34th Meeting of the General Assembly (Shanghai, China) as distributed and posted on the I-INCE website. There were no comments. The minutes were approved without modification.

5. Report of the President

President Daigle reported on the current state of the International Institute of Noise Control Engineering as follows:

- I-INCE currently has 42 Members from 36 countries, 8 Sustaining Members and 6 Institutional Members.
- A new initiative of the Institute is to provide young scientists/engineers grants of approximately 500 EUR to attend Inter-Noise Congresses. 10-12 grants will be made for the 2010 Inter-Noise Congress in Lisbon, Portugal. Details will be posted on the website and distributed to the member societies by email.
- President Daigle noted that there will be a CAETS Forum on Monday through Wednesday of the Congress. It is chaired by T. Kihlman. Information was also provided in the congress registration information packets.
- The President reported that the Board of Directors elected the following Officers and Directors of the Institute.
 - President-Elect – J. Scheuren (3 year term)
 - Secretary General – R. Bernhard (3- year term)
 - Treasurer – J.P. Clairbois (1-year term)
 - Vice President – Europe/Africa Region, L. Maffei (3-year term)
 - Vice President – Pan-America Region, P. Donovan (3-year term)
 - Vice President – Communications, G. Maling (4-year term)
 - Vice President – Global Noise Policy, T. Kihlman (4-year term)
 - Vice President – Rules & Governance, B. Lang (4-year term)

The entire slate of Officers and Directors is appended as Attachment 2.
- The President reported on Inter-Noise series planning

- Inter-Noise will be held 2010 June 13-17 in Lisbon, Portugal
- Inter-Noise will be held 2011 September 4-7 in Osaka, Japan
- Inter-Noise 2012 will be held in the Pan America Region. The board is currently in negotiations with the host society. The date and venue will be announced as soon as possible.
- Inter-Noise 2013 will be held in the Europe/Africa Region. The Congress Selection Committee reviewed three informal proposals. These three Member Societies will be invited to make formal proposals next year and a final selection will be made based on those proposals.
- Inter-Noise 2014 will be held in the Asia/Pacific Region.

6. Report of the Secretary General:

I-INCE Secretariat

The Secretary General reported that the Secretariat is at the University of Notre Dame. The Secretariat is functioning well. The immediate challenge of the Secretariat is communications with Member Societies. Anyone interested in being a friend of the International Institute of Noise Control Engineering who would like to receive copies of emails distributed to Member Societies to follow-up on those actions is invited to offer their email address on the roster form so that they can be informed of future activities.

The Secretary General reported that there are no Member Society actions required.

7. Report of the Treasurer:

Financial Report

The Treasurer gave the report of the 2008 budget which has been closed. The report is appended as Attachment 3. The Treasurer reported on the status of the 2009 budget. Budget items seemed to be in line with the projected budget shown a year ago. The 2009 budget is appended as Attachment 4. The proposed 2010 budget was discussed. Each of the significant items of that budget was discussed by the Treasurer. The projected budget for 2010 is appended as Attachment 5. There were no comments or questions from the General Assembly delegates

8. Election of Membership of the Congress Selection Committee

The slate of members of current Congress Selection Committee was reviewed. It was noted that there are three open positions on the member slate; R. Hellweg from the Pan America Region, Y.H. Kim from Asia Pacific Region, and T. Gjestland from the Europe/Africa Region. It was also noted that the Vice President for Europe/Africa for 2010-2012 will be L. Maffei and the Vice President for Pan America for 2010-2012 will be P. Donovan. Three nominations were presented from the floor; T. Gjestland from the Europe/Africa, C. Burroughs from the Pan American Region and T. Ho from the Asia Pacific Region. No other nominations were offered. Since there three positions to be filled, the slate was accepted by acclamation. The membership of the 2010 Congress Selection Committee is appended as Attachment 6.

9. Inter-Noise 2009

T. Nightingale, President of Inter-Noise 2009 reported at the time of the meeting there were 657 papers at the conference; 575 of these would be presented as oral papers, 75 as posters and 7 as distinguished lectures. The CAETS forum would be conducted in parallel with the technical sessions of the congress. The Exhibition has 56 booths. The attendance preregistered for the

Congress includes 815 individuals including 626 full registrants, 123 students and 66 accompanying persons.

10. Inter-Noise 2010

J. Patricio, President of Inter-Noise 2010, gave a presentation on the status of planning for Inter-Noise 2010. The Congress will be held in Lisbon, Portugal 2010 June 13-17. The theme of the Congress is Noise & Sustainability. President Patricio presented a video description of the city and the venue for the Conference.

11. Governance

W. Lang reported that over the next year a review will be conducted of the By-Laws of the Institute, the Rules of the Institute and the duties and responsibilities of the Officers. As appropriate, changes will be brought to the General Assembly for review and/or approval.

12. Report of the Vice President for Technical Activities

Technical Study Groups

R. Singh reported on the progress of the Technical Study Groups (TSG).

- TSG1 has prepared a comment draft which is currently being edited and will be sent to the Member Societies for review.
- The TSG3 report is posted on the I-INCE website. The effort is complete and the TSG has been disbanded.
- The effort of TSG6 is 99% complete. They expect to have a comment draft available to be sent to the Member Societies soon.
- TSG7 has developed a new mission which has been approved by the Board of Directors. TSG7 will include contributions from the CAETS Forum. The information gathered at the CAETS Forum will be included in the TSG7 report.
- TSG8 has been abandoned. The preliminary findings of TSG8 have been distributed to an 'education' task force chaired by D. Holger.
- The proposal for TSG9 – Metrics for Environmental Noise Assessment & Control has been distributed to the Member Societies. The Member Societies voted 11 for, 1 against. The General Assembly was asked to approve the formation of TSG9. The General Assembly approved by acclamation. TSG9 met on Sunday morning.

Future Congress Technical Planning Committee (FCTP)

R. Singh reported that there will be a Future Congress Technical Planning Committee (FCTP) on 26 Aug from 13.40 – 15.20. The organizers of Inter-Noise 2009 report that approximately one-third of the technical program of the congress came from the FCTP that was conducted in 2008 in Shanghai. The meeting of the FCTP will consider the technical programs for both Inter-Noise 2010 and 2011.

R. Singh also reported the future tasks of the Vice President for Technical Activities will include updating the I-INCE website technical activities sections and to finish the Technical Study Group reports that are currently in progress.

13. Report of the Vice President for Communications

Noise News International (NNI)

G. Maling reviewed all of the details of current NNI distribution. He then reviewed the budget for

NNI. For last fiscal year, NNI ran a greater than 31,000 USD shortfall, which was paid up by INCE/USA.

Starting next year, NNI will be distributed in pdf format only. There are many advantages of this type of distribution. We will be able to achieve wider circulation and delivery will be immediate. We will be able to provide hot links to advertisers, use color throughout, cost will be lower and we will be able to find money in the budget to hire a professional editor. The format will also allow us to add issues of NNI to the archives that date back to 2003. A draft media kit for advertisers has been prepared. A website has been created by J. Cuschieri at noisenewsinternational.net. Distribution for INCE/USA would be accomplished by informing members about possible download of the document. For all Member Societies of I-INCE there will be a location on the website to register if they want email delivery of NNI or to receive notification that the issue has been posted. The NNI issue will be posted on a website, and those who register, will be notified when it is posted so they can do their own download.

Noise Control Engineering Journal (NCEJ)

C. Burroughs reported on the status of the Noise Control Engineering Journal (NCEJ). In 2008 there were more than 100 submissions. In 2009 there are projected to be more than 100 submissions as well. The last three issues have had more than 10 papers each. The time from submission to publication is approximately 9-10 months. This year there were three special issues; one on tire pavement noise that had 11 papers, one on fan noise that had 10 papers and one on workplace noise that had 6 papers. The Journal is on schedule. There are three special issues planned; one on soundscapes, one on military noise and one on wind turbines. By the end of the year, the CD ROM for NCEJ will hold approximately 200 papers.

C. Burroughs also reported that NCEJ subscriptions are now available to individuals. INCE/USA members, plus Member Societies of INCE currently receive NCEJ. INCE/USA is making a stand-alone subscription possible. Interested individuals can contact INCE/USA. Libraries with subscriptions now receive only electronic copies of NCEJ. Individual NCEJ papers are available on-line for \$4USD per download. The fee is priced specifically to only cover costs.

On-line

C. Burroughs also reported on online access to INCE documents. Currently all 750 papers of NCEJ are available. There are 8227 conference papers, including all conference papers from Inter-Noise 1995 – Inter-Noise 2007. Papers from Inter-Noise 94 and Inter-Noise 2008 are ready to be posted. This will add 1100 more papers. In the future, additional Inter-Noise papers will be added back to Inter-Noise 92 and there will be additional historical NCEJ papers added to the electronic database.

14. Other Business

There was a discussion about the I-INCE effort to write a report for CAETS. The findings of the workshops thus far have pointed out that a 10-20 dB reduction of noise is needed at the source. Policy changes are needed in order to accomplish this goal. The second CAETS forum will be this week at the Congress venue. The two CAETS workshops will be summarized for CAETS. In order to implement the recommendation, it would be useful if practitioners from several countries would volunteer to pursue and test the recommendations of the report.

15. Time and place of the next meeting

The next meeting of the I-INCE General Assembly will be 2010 June 13 in Lisbon, Portugal . Time and place will be announced.

16. Closing of the meeting

I-INCE President Daigle closed the 35th meeting of the I-INCE General Assembly at 14.40.
