SUNDAY, 2020 August 23, 21.00 to 23.30 (Seoul)

#### **International Zoom Meeting**

### 1. Opening:

The 46th meeting of the General Assembly of the International Institute of Noise Control Engineering was convened at 21:00 on Sunday, 2020 August 23 by I-INCE President Robert Bernhard over a Zoom meeting conference call.

#### 2. Roll Call of Delegates:

The roll call of the Member's Societies Delegates was conducted by the Secretary General, Paul Donavan. Attendance of representatives of Member Societies was recorded from Zoom Chat responses and/or through email responses sent to the Secretary General. The responses were as follows:

#### 3. Adoption of the Agenda:

The Secretary General, Paul Donavan, presented the agenda (Attachment 1) of the meeting and asked if there were any questions or additional items for the agenda. There were none.

### 4. Approval of the minutes of the 45th Meeting held in Madrid, Spain 2019 June 16

The Secretary General asked for any comments or suggestions for the previously circulated Minutes of the 2019 General Assembly meeting via the chat feature or email. None were received, the Minutes were considered as approved as written. The minutes are posted on the I-INCE website.

#### 5. Report of the President

President Robert (Bob) Bernhard reviewed the I-INCE current activities with an update and the major issues to be addressed in the remainder of 2020 and on into 2021. He reviewed the structure of the organization which is an international grouping of member societies concerned with noise control.

Bob then discussed the current and future I-INCE Congresses. Due the global pandemic, the 2020 Congress is being held virtually as organized in Seoul, Korea. In 2021, the Congress will be in Washington, D.C., USA marking the 50<sup>th</sup> anniversary of the INTER-NOISE Congress series, which was also held in Washington, D.C. in 1972. INTER-NOISE 2022 will be held in Glasgow, Scotland August 21 through 24, 2022. For INTER-NOISE 2023, the Congress will be in the Asia-Pacific Region at a location to be identified later after the Congress agreement has been signed. INTER-NOISE 2024 is to be held in the Europe-Africa geographical region. The Congress Selection Committee (CSC) reviewed three informal proposals from Member Societies of that region and all three organizing teams will be invited to the 2021 CSC meeting to present formal proposals for hosting the Congress. For 2025, proposals for the Congress will be from the Pan American region at the 2021 CSC meeting.

Bob then gave an overview of I-INCE Technical Activities including the Young Professionals Program, the data base of all INTER-NOISE papers available to individuals through their Member Society, and the I-INCE Symposia series. These issues are discussed further in the reports of the Vice President of Technical Activities and the Vice President of Communications & Webmaster.

Concerning administrative issues, Bob reported on the efforts of I-INCE Leadership to get the organization legal registration updated. I-INCE was initially registered in Switzerland in 1974 without much official documentation of that registration. In recent years, there has been requests for more official documentation, particularly from the banks used by I-INCE. Joachim Scheuren, I-INCE Past President (2017-2019), has been pursuing this with the Swiss authorities over the past few years and it appears that this will be resolved in the coming year. Bob also noted that communication between I-INCE and its Member Societies and individual members of those societies remains a challenge and requested ongoing assistance with this issue. This is particularly a problem for the distribution of Noise News International (NNI) to individuals in the Member Societies. He reported that the Board of Directors is also concerned about the format of future Congresses given current and potential travel restrictions and the possible

impact on future attendees' preference for non-in-person Congresses. The Board has formed a committee chaired by President-Elect Luigi Maffei to prepare guidance to future Congress organizers on this issue.

#### 6. Report of the Secretary General

The Secretary General, Paul Donavan reviewed the items included in the written report (Attachment 2). Regarding the request from SOBRAC, the General Assembly approved their request to be reclassified as a small Member Society. SOBRAC currently has about 50 members.

#### 7. Composition of the I-INCE Board

President Bernhard presented the report of the nominating committee (Attachment 3) which had been accepted by the Board at their meeting previously. For the position of Director-at Large, Europe-Africa, one nomination was received for Kristian Jambrošić (Attachment 4) from the Acoustical Society of Croatia. Kristian was introduced and he reviewed his background with the Acoustical Society of Croatia, the European Acoustical Association, and interests in acoustics. Kristian was elected without dissent.

#### 8. Report of the Treasurer:

The I-INCE Treasurer, Doug Manvell, presented the Treasurer's Report (Attachment 5) for 2020. Doug first reported on the audited financial outcome of 2019. The 2019 net income was almost 6,000€as opposed to the budgeted loss of 11,210€ primarily due to a greater than excepted income from INTERNOISE 2019. Expenses for functional costs were 5,000€lower than budgeted and expenses for scientific support lower by 1,000. In regard to I-INCE financial status for 2019, total assets were 223,254€and liabilities were 16,828€leaving a total equity of 206,426€ In comparison to 2018, Doug reported that the equity has increased by 3,816€in 2019. The Auditor's Report was approved without dissent.

Doug reviewed the status of the 2020 budget. As of 16 July, membership dues had been received from all but one Member Society (see Report of the Secretary General). INTER-NOISE 2020 is now expected not

to have a positive income due to the shift to a virtual format. If a profit is produced, an income sharing plan between INTER-NOISE 2020 and I-INCE has been developed, however, no income to I-INCE is now in the updated 2020 budget. The expenses for scientific support is now expected to be lower by about 7,200€due to the virtual INTER-NOISE and functional expenses are also expected to be lower. As a result of these developments, expenses are expected to exceed income by about 28,000€reducing equity by about 13,000€ Although the I-INCE equity is expected to be reduced by about 15 percent, it is expected that the equity could carry I-INCE through 3.6 years of operation in the absence of no additional income. President Bernhard added that the invested reserve is intended for use in unforeseen situations such as the organizers of INTER-NOISE 2020 are having to deal with.

Doug presented the initial draft budget for 2021 which was still under discussion by the Board. This budget currently indicated a loss of 11,245€based on unchanged membership dues. The income budget from INTER-2021 is the same as originally budgeted for 2020, however, there is uncertainty about the format of the Congress which could impact this projection. The scientific support is similar to previous years exclusive of the one-year 2020 10,000€item for the 2020 International Year of Sound. Altogether, the budgeted loss is 11,245€ At the subsequent Board meeting, the budget was approved as presented to the General Assembly.

At the Board meeting prior to the General Assembly, Norm Broner was approved as the auditor for the I-INCE 2020 finances. There were no objections from the General Assembly.

#### 9. Membership of the Congress Selection Committee (CSC)

The Chairman of the Congress Selection Committee, Luigi Maffei, reported on the proposed composition of the CSC for 2021 (Attachment 6). Every year one regional member from each of the three regions needs to be elected to serve on the committee. The terms are for three years and there are 3 members from each region. Membership is restricted to two terms. Candidates are identified and nominated by the three I-INCE regional Vice Presidents and the committee Chair. For 2021, the following candidates were nominated for the three-year terms:

- Europe/Africa Region Stephen Martin Dance (Attachment 7), South Bank University, London, UK, Fellow of the Institute of Acoustics IoA, Theme and session organizer at several congresses (ICSV, CIBSE, EAA/ASA).
- Pan America Marcos Holtz (Attachment 8), Partner-Director Harmonia, Brazil, Vice-President of Technical Activities, 2018- 2021, ProAcustica Association, Member of Acoustical Society of Brazil (Sobrac).
- Pacific Region Akira Omoto (attachment 9), Faculty of Design, Kyushu University, Fukuoka, Japan, Board Member and Vice President of the Institute of Noise Control Engineering of Japan, Board Member and Vice President Acoustical Society of Japan.

These nominations were accepted without comment or further discussion.

#### 10. Report on INTER-NOISE 2020, Seoul

I-INCE President Bernhard reviewed the presentation prepared by Yeon June Kang, Congress Secretary General, provided information and statistics on the INTER-NOISE 2020 (Attachment 10) being held in Seoul 2020 August 23-26. There were 836 registrants including 316 students. Bob noted that the higher than normal student registrations may have been due to low student registration fee and the absence of travel cost due to the virtual Congress.

**11. Report on planning for INTER-NOISE 2021** (Washington, DC) and **INTER-NOISE 2022** (Glasgow) by members of the Congress Organizing Committees

Raj Singh, the Congress President of INTER-NOISE 2021, reported on the plans for the Congress to be held in Washington D.C. 2021 August 1-4 (Attachment 11). Raj stated that they are considering a hybrid or virtual congress depending on travel restrictions in 2021. Barry Gibb, the Congress President of INTER-NOISE 2022, reported on the plans for the Congress to be held in Glasgow August 21-24 (Attachment 12). More information can be found on the Congress website, <a href="http://internoise2021.org/">http://internoise2021.org/</a>.

#### 12. International Year of Sound

Past-President Marion Burgess provided an update of the International Year of Sound 2020 (Attachment 13). Due to international travel restrictions and cancelation of some planned activities, the IYS has been extended into 2021. The IYS was initiated by the International Commission for Acoustics in conjunction with La Semaine du Son. I-INCE is identified as a founding member of IYS and sponsored the short film, Sounds of Our Life available at <a href="https://www.youtube.com/watch?v=Y6HgT1iujwQ&t=2s">https://www.youtube.com/watch?v=Y6HgT1iujwQ&t=2s</a> and the IYS website.

#### 13. Report of the Vice President for Technical Activities

Vice President for Technical Activities, Patricia Davies, reported on the technical activities (Attachment 14) of the I-INCE. She reported that there were 20 I-INCE Young Professional travel awardees given for 2020 and that since 2010, 187 travel grants have been awarded. She introduced Osman Taha Sen of the Technical University of Istanbul who coordinates the Young Professionals Program.

#### 14. Report of the I-INCE Vice President for Communications and Webpage

Joe Cuschieri, Vice President for Communication and Webmaster, reported on the activities relating to communications (Attachment 15) and the web page including Noise News International (NNI), Noise Control Engineering Journal (NCEJ), the On-line Digital Library, and the I-INCE web site. NNI is published quarterly in PDF format with an announcement sent to I-INCE Board Members and the Member Society contacts for distribution to their members. He also requested assistance from the Member Societies in assuring that these announcements are distributed. NNI also maintains a blog and social media presence and has begun producing podcasts. For the On-Line Digital Library, Joe noted that to date, only limited number of Member Societies have taken advantage of distributing access to their membership. Joe outlined two methods for accessing the library in his report. For the I-INCE website, Joe requested ongoing support from the Member Societies in keeping the information as posted on the website up to date by emailing changes and updates to him for uploading.

#### 15. Other Business

President Bernhard thanked Joachim Scheuren for his work on the legal registration of I-INCE. He also expressed gratitude to André Fiebig and Yeon June Kang for their work on the I-INCE Board and to the organizers of INTER-NOISE 2020.

#### 16. Next Meeting

The 47<sup>th</sup> meeting of the General Assembly of I-INCE is tentatively planned for 2021 August 1 at 13:00 (Washington, D.C.), prior to the opening of INTER-NOISE 2021. The location and format will be determined and announced when available.

#### 17. Close

The meeting was adjourned at 23:20 (Seoul) by President Bernhard

### **Membership**

We still have not succeeded in getting a completed membership application from the Tunisian Association of Industrial Acoustics and Vibrations as reported by the VP Europe-Africa.

SOBRAC has requested having their status size being changed from medium to small. This needs to be approved by the General Assembly. As a side note, I still have not been able to find numerical definitions for our member categories. It appears that a Member Society can declare what they are, and GA approves it. SOBRAC also informed us they can not pay their fees for 2020 but expect to in 2021. Assuming they do not pay their fees by October 15<sup>th</sup>, they become "delinquent" and would have to be re-instated by action of the GA.

### **Video Conferencing**

I have purchased two Zoom licenses for I-INCE, one for the President and one for the Secretary General. With these licenses, other Board members can create Zoom meetings for I-INCE purposes through the SG or President, however these officers must generate the meeting and at least initially host the meeting.

### **Communication**

The number of "bounce-backs" from mass membership emailings has not been as many compared to previous years, typically, two per mailing out 60+ recipients. Communications has generally improved.






